Succession and role of ISKCON Ireland National Council:-

IINC is responsible and to be consulted as to the changes of management of ISKCON in Ireland:-

GBC/SPT Dev Org committee had proposed contiguous zones, as the GBC zone it includes UK/Ireland as one zone for GBC:-

A position of Regional Secretary/ Euro Divisional Secretary who spends all his time and coordinates activities in Ireland had received a consensus of IINC:-

Temple Presidents are equally key positions in Prabhupada's system of management as GBC representatives. GBC and Regional/National representative should ideally be impartial, not local yet Ireland based. Ideally current TPs fill in the post. Premarnava das confirmed as TP for Dublin centre.

Budget:-

National accounts summary – position is open for nomination. PR confirmed that all accounts of restaurants are already audited by an external auditor. Costs of National Accounting summary and fundraising campaign co-ordinator nomination (proposed Tim McEvit) is to be confirmed by the next meeting. ISKCON asrama residence requirements in Ireland:-

Asrama residence requires residents to follow four regulative principles. It may be a disqualification for using the facilities of the asrama for persons with alternative sexual orientation if it has been revealed or became known in the past.
